# PC 2023/68 Actions from previous meeting and Clerk's report

- 1. Certificate in Local Council Administration Support Course it was **APPROVED** to pay for the 4 day SALC course at a cost of £300
- 2. Data Protection and GDPR for Clerks and Officers Part 1 (Foundations and Theory), Part 2 (Accountability and Lawfulness) and Part 3 (Rights and Information Security) £35 each – all 3 courses APPROVED in principle. The Clerk will attend Part 1 and later book for Parts 2 and 3 if deemed appropriate
- **3.** The Transparency Code for smaller authorities cost £35 it was **APPROVED** for the Clerk to attend

- One member enquired about a Neighbourhood plan. Cllr Semmons advised it is very costly and time consuming; the quickest Plan has taken 14 months. It was **RESOLVED** that Cllr Semmons will make enquiries with North Cadbury Parish Council and report back on his findings

# PC 2023/72 To discuss village signs for Sutton Montis

Members of the public were divided on the whether there should be signs in Sutton Montis. Some thought it would be helpful to delivery drivers and visitors as people do not realise they are in Sutton Montis, others felt it would spoil the aesthetic appearance of the village. It was **RESOLVED** that all residents should have opportunity to comment and the matter will be **DEFERRED** to the next meeting. The Clerk will prepare a draft feedback questionnaire for residents for approval at the next meeting and check with Somerset Highways regarding the type of signs permitted

# PC 2023/73 To discuss 20 mph speed restriction for both villages

Many concerns were raised about the speed of traffic through both villages however it was noted without a speed restriction vehicles can legally drive within the national speed limit. Near misses were reported with walkers, children and cyclists. The cost of implementing a 20 mph speed restriction will be approximately £15000. Public opinion was divided – some felt motorists would disregard a speed reduction however others felt the impact of signs would help reduce speed. It was **RESOLVED** that the Clerk will enquire about the cost of SIDS and obtain feedback from other parishes that use them. The item will be **DEFERRED** to the next meeting for opinion to be sought on the feedback form from all residents

#### PC 2023/77 Highways

- 1. Sutton Road there is no conclusive update but the residents group has received acknowledgement of their report from planning enforcement officer Heather Nesbitt who advised she will be the point of contact and was going to visit the farm. She welcomes new information and will confer with others to discuss next steps. The Clerk reported that Queen Camel Parish Council has noticed increase lorry activity through the village. Cllr Cook advised the report has not been sent to the Traffic Commissioner's Office as the complaint relates to alleged lack of planning consent for the transport operation and non-agricultural related activity
- 2. A303 slip roads Somerset Council has accepted responsibility for part of the roads north and southbound and has provided map extracts. They confirm the roads will be prepared but are not a priority. The southbound slip road falling under National Highways responsibility has been reported to by the Clerk
- 3. Potholes around the village the Clerk confirmed that most have now been repaired but will new or worsening ones will continue to be reported. Wessex Water have been working on the leak on Church Road below the Camelot and it appears to be resolved

#### PC 2023/78 Rights of Way

1. Condition of footpaths and bridleways

A public member reported that Monarchs Way goes through the parish and it is difficult to get over the stiles which are overgrown with lots of brambles. Also, at Corton Wood Farm the course of the footpath has been changed, there are no bridle path signs and the gate has been locked. Details will be sent to the Clerk to report to Somerset Council Rights of Way officer
