Parish Council domain name

Guidance continues to be received from central government urging parish councils to move to a gov.uk domain name. Clarification has been sought from our web provider who has confirmed at present this is not mandatory but recommended and most of the "security concerns" raised in the guidance are already covered for non .gov.uk domains and websites hosted through Westernweb Ltd

Campaign to Protect Rural England (CPRE) membership

Email sent 03/06/2025 refers. CPRE is the countryside charity campaining hard for the countryside, locally and nationally. They are lobbying MPs to amend the Planning & Infrastructure Bill which threatens to reduce local democracy in the planning system. Membership is £5 per month and includes the Countryside Voices magazine, local newsletters, discounted entry to national attractions and gardens, invitations to Somerset events and membership of the local and national CPRE charities

Defibrillator

The problem of the electrician not being able to issue a Certificate of Minor Works for the defibrillator in South Cadbury needs resolving. HF Miles have advised the workshop has never been earthed as it connects directly to the electric pole in the road. Whilst the third party risk from an incident is low I am confident our insurance would be invalid as the electrician is unable to issue the Certificate.

I have asked about slabs being positioned under the defibrillator to reduce the risk of slipping in wet weather. HF Miles have agreed but have asked for the parish council to provide the slabs
